DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a very small, three story building two bays wide. It is constructed of brick painted white with white wood trim and topped with a flat roof.

The first floor has been altered from the original and now has a metal and glass commercial front with the entrance to the south. On the second and third floor the windows have plain wood sills and jambs and over them a variation of elliptical-head pediments. The windows themselves are wood double hung with 1/1 sash. At the top of the wall there is a small architrave, a frieze which is a continuation of the wall, and a typical cornice having modillions. The whole entablature is broken with consoles at the ends and in the center.
