DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached pair of two story, brick houses, four bays wide and three deep with a two story, "T" shaped wing, three bays wide and two deep with side balconies and a newer block extension on #11. Brickwork is in unpainted common bond. Front entrances occupy the end bays with glass paned doors and are topped by segmental transoms with high header over stretcher brick arches and scrolled infills as above all front windows. All house windows are of 2/2 sash and those on the rear have wood lintels and sills. The front roof slopes to the rear and the wing has a low "A" frame, both being of metal. The front Victorian cornice is "V" shaped with bands of mouldings, rounded dentils, and bays accented by small, moulded brackets topped by crockets of geometric floral designs. The building rests on a low fieldstone foundation.
