DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This building is a three story structure built of a dark brown brick in common bond with raked joints. The trim is of several kinds. First is a light gray stone used sparingly for ornamentation, next is wood painted a dark red-brown used for the windows, and third is a dark red-brown brick closely matching the wood trim. This brick is used for decoration of the wall surface. The front is in three bays, a large center one and a smaller bay to each side. The bays are recessed by pilasters at their sides and arches above each bay. The arch above the center bay is, of course, much higher. The roof of the building is flat.

The first story front is a contemporary metal and glass storefront. Over the entrances and signplate is a stone band immediately below the second floor window sills.

At the second and third story levels there are three windows in the center bay and one in each side bay. All windows are wood, double hung with 1/1 sash. The sills are stone and the lintels are an upright course of brick. In each bay between the lintels of the second story windows and the sills of those above, is an ornamental brick panel bordered with the dark reddish-brown brick. In the center of the panels is a small square stone. In the side bays over the third story windows, but still inside the arches recess, is a similar panel, but the stone block in the center is set with the corners up - so as to be a diamond.

Above the arches of the flanking bays is a small wood cornice supported on consoles. Over the arch of the center bay the building's name and date (1915) is set in the masonry. There is a brick parapet on the top of the wall which is curved upward over the center bay. This has a stone parapet cap on it.
