DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#10 is a small, detached, two story brick house, two bays wide and three in depth with a two story, brick "L" shaped wing, 1-1/2 bays square and a side balcony. All brickwork is in common bond. A four panel door with a narrow overlight occupies the right (W) bay and is approached by a high, six step wooden porch with a seat. Front windows are of 1/1 sash and wing windows are of 2/2 sash, both with wood lintels and sills. The front section roof slopes to the rear and the wing has a shed roof, both of metal. The front roofline has an attractive, simple, Victorian "V" shaped cornice decorated by a band of incised crosses, small curved dentils and mouldings and ended by small, fluted and moulded brackets. The house sets on a high fieldstone foundation and the cellar half above ground level.
