DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#13 is a 2-1/2 story, brick house detached on the right (E) side except for a newer garage, and is three bays wide and two deep with a two story, brick "L" shaped wing, two bays wide and four bays long, a side balcony and a newer, one story, brick extension. All brickwork is in common bond and the front has been restored. The front entrance occupies the left (W) bay with a newer door and segmental arched brick transom as above. All front windows are of 1/1 sash with wrought box grills on the first floor. Rear area windows are of 2/2 sash with wood lintels and sills. The attic is lighted by a small window on the right side. The front section has a steep slope "A" frame roof resting on a three string brick cornice on the front with the middle row set on the diagonal and the rear cornice is of two strings of brick. A small enclosed chimney rises from the right gable. The wing has a shed roof and both are of metal. The house rests on a low fieldstone foundation.
