## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story, attached pair of brick houses, four bays wide and approximately three bays in depth with a two story, brick "T" shaped wing, three bays wide and two deep and rear balconies. All brickwork is in common bond. Simple front entrances occupy the outer bays with a newer door on #17 but possibly an original glass paned door on #15, and both have round arched transoms. These also have white marble sills and 19th century, ornate cast iron porches. The inner bays of the first floor have elliptically arched, wide, double windows with moulded mullions. Second story front windows are segmentally arched, and all front windows are of 1/1 sash with brick header arches. Rear area windows are of 2/2 sash with two row header segmental arches. The front section roof slopes to the rear and the wing has a low "A" frame and both are of metal. The front roofline has a Victorian "V" shaped cornice decorated by bands of incised crosses and other designs, curved dentils and mouldings. Long moulded and grooved brackets divide and end the houses and are topped by rounded acroteria bearing roundels. The building sets on a high fieldstone foundation. There are flat, iron cellar doors in the pavement inscribed with "*Henry Pampel, Frederick, Md.*" and decorated by foliage designs. #17 retains a herringbone brick pavement.
