**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a 2-1/2 story pair of attached brick houses, five bays wide and approximately three bays in depth with two story, brick "U" shaped wings, 1-1/2 bays wide and two bays in depth with end balconies. All brickwork is of common bond. Front entrances occupy the end bays with #19 having a newer, metal lintel and newer door and #21 retains an original, four panel door topped by a segmental arched transom of two rows of headers with the bottom row recessed and centered by a tall, brick keystone. The infill is adorned by incised scrolls and roundels. These arches also head the 2/2 sash front windows and the center passageway to the rear yards and with a turned, spindle grillwork. Rear area windows are of 6/6 sash with wood lintels and sills. The attics are lighted by a 6/6 sash, peaked dormer window on the rear of each house. The front section has a steep "A" frame roof resting on a three string brick cornice with the center row in dentils on the front and a two string cornice on the rear. Double flue enclosed chimneys rise from each gable and the center of the ridge. The wing roofs are rather flat and all are of metal. The building sets on a rather high field-stone foundation.
