DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#25 is a 2-1/2 story, frame, detached house, four bays wide and three in depth with a 1-1/2 story, frame "L" shaped wing, approximately four bays long and two wide and a rear, one story, block extension. The front and rear are covered by clapboarding and the sides by a stone design tarpaper. A four paned door occupies the second bay from the left (W) side and a newer door on the right. These are approached by twelve steps leading to a high, wooden porch with the floor 8' above pavement level. The two front windows are of 2/2 sash and side windows are of 6/6 sash. The attic is lighted by small windows in each gable. The front section has a moderate slope roof with a double flue enclosed chimney on the left side. The wing has a steep slope "A" frame roof and both are of metal. This house sets on an outcropping of fieldstone with the cellar at ground level and with built-up walls 8' high. The front of the cellar is entered by a full-sized door and the 4/4 basement sash windows on the front and alley side are protected by four panel shutters.
