**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a 2-1/2 story detached pair of brick houses, six bays wide and two in depth with a two story, brick "T" shaped wing, four bays wide and two in depth and side balconies. There is a newer, one story extension to the rear of #117. The front of #115 has been refaced with a new, thin pressed brick, but #117 retains the original facade in common bond.

Front entrances occupy the left bay of each house with newer doors and segmental arched transoms. #115 has 2/1 sash windows, but #117 has 2/2 sash on the second story and 1/1 sash on the first, both with segmental brick arches. The rear of both houses have 1/1 sash windows with wood lintels and sills. The attics are lighted by a small window in each gable.

The front section has a steep, metal "A" frame roof resting on three string brick cornices. Small enclosed chimneys rise from each end and on the left of #115. The wing has a rather flat "A" frame roof. The building rests on a low fieldstone foundation.
