**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a 2-1/2 story detached pair of brick houses, six bays wide and two in depth with a 2-1/2 story, brick "T" shaped wing, four bays wide and four longer bays in depth with side balconies. The front facades of both houses have been refaced with new, thin pressed brick. Front entrances occupy the inner bays with newer doors and segmental brick transoms. The front windows are of 2/2 sash on the second story and 1/1 sash on the first, both with segmental brick arches. Rear area windows remain mostly 6/6 sash with wood lintels and sills. Attics are lighted by small windows in each gable.

The front section has a steep, metal "A" frame roof resting on three string brick cornices, now covered. Small enclosed chimneys rise from each end and on the left of #119. The wing has a moderate slope "A" frame roof.

The building rests on a low fieldstone foundation.
