DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story pair of attached brick houses, five bays wide (#120 being three bays) and two in depth with two story, frame "U" shaped wings, one bay wide and two in depth with side balconies. Brickwork is in common bond and the wings are sheathed by either German siding or asbestos shingles.

Simple entrances occupy the second bay from each end with newer doors and old, three pane overlights. The center bay contains an enclosed passage to rear yards which is fronted by a board and batten gate and a Victorian-cut grill above.

Most house windows are of 6/6 sash with 2/2 sash in the wings. These have wood lintels and sills with front lintels decorated by top mouldings. A small, peaked dormer window lights the attic from the rear of #122.

The front section has a steep "A" frame metal roof resting on two string brick cornices and small enclosed chimneys rise from each gable.

The building rests on a rather low fieldstone foundation.
