DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story building three bays wide built of dark brown brick in common bond with light tan stone for trim. The roof is flat and houses two stores on the first floor and a studio on the second.

On the first floor, most of the front wall is filled with two metal and glass storefronts, but there are three columns of the original brick still showing at the corners and between the storefronts. To the south is the entrance to the second floor. This is a doorway with a parabolic arch transom made of wood painted white. Over the storefront at #35 N. Market is a copper awning.

On the second floor level there are three windows, double hung with 1/1 sash. Their sills are stone and for lintels they have stone blocks with fluting decoration to either side of larger stone blocks with basket designs in them. There are quoins at the corners of the buildings and in the jambs of the windows.

Above the window lintels is a heavy stone cornice over which is a brick parapet. This has breaks between the bays and these also have quoins on them. A stone parapet cap finishes the wall.
