DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#123 is a 2-1/2 story detached brick house approximately three bays square with a two story, frame "L" shaped wing, two bays wide and four in depth with a side balcony and set at an angle to the front section. Brickwork is laid in common bond while the wing is sheathed in German siding and asphalt shingles.

A newer, small paned door occupies the right bay with an old, three pane over-light. Most house windows remain 6/6 sash with wood sills and lintels as above the doorway, and front windows are protected by louvered shutters. The attic is lighted by six pane windows in both gables. A covered porch supported by turned pillars fronts the house.

The front section has a moderate slope, "A" frame roof of metal resting on three string brick cornices. Small enclosed chimneys rise from each gable. The wing has a shed roof.

This house sets on a rather high fieldstone foundation.
