DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#126 is a 2-1/2 story brick house detached on the right side, approximately three bays square with a two story, brick "L" shaped wing, one bay wide and two in depth with a side balcony.

The front entrance occupies the off-centered, middle bay with a newer door and old, three pane overlight. To the left is an enclosed passage to the rear yard fronted by a board and batten gate headed by Victorian-cut grillwork.

Front windows are of 1/1 sash headed by segmental brick arches of two rows of headers projecting in the form of a drip mould. Rear area windows are of 6/6 sash with wood lintels and sills. The attic is lighted by two small, four pane windows in the right gable.

The front section has a steep slope, metal "A" frame roof resting on two string brick cornices. An enclosed, double flue chimney rises from the left side. The wing has a metal shed roof.

The house rests on a low fieldstone foundation.
