DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick house detached on the left (N. Bentz Street) side. It is three bays wide and two in depth with a two story, brick "L" shaped wing attached on the angle of the side street. It is approximately two bays square with a side balcony and a newer, one story extension. All brickwork is in common bond

The front entrance contains a newer door in the center bay. All front windows are now of 1/1 sash with wood lintels and sills, as above the door. This is approached by a brownstone stoop. Wing windows are of 6/6 sash, also with wood lintels and sills. The attic is lighted by a small, four pane window in each gable.

The front section has a moderate slope, metal "A" frame roof resting on two string brick cornices with small, enclosed chimneys rising at each end.

The building rests on a low fieldstone foundation.
