DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#132 is a 2-1/2 story detached brick house with the first floor now used as a liquor store. It is five bays wide and approximately three in depth with a small, one bay square, 1-1/2 story original brick wing on the left rear side. Other modern additions are to the rear and side. All brickwork is in common bond. The first floor contains large pane shopwindows and doors. Second story front windows are now of 1/1 sash with moulded top wood lintels decorated by protruding moulded end blocks. The attic is lighted by a small, four pane window in each gable. The front section has a moderate slope, metal "A" frame roof resting on two string brick cornices and double flue enclosed chimneys rise from each side. The original wing has a steep sloped, metal shed roof. The building rests on a low fieldstone foundation.
