DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#22 is a small, low frame house, 2-1/2 stories in height and setting back from the street being attached on the right (W) side. It is two bays wide and four bays deep with the gable end on the front. There is a small, one story, frame extension on the rear. This building, by its shape and small size, appears to be of log construction and is now covered with composition siding. A low, four panel door occupies the right (W) bay with a small, 2/2 sash window to the left, in the front gable, and on the exposed side. On the second story of this side are small, narrow, six pane windows. The rear of the attic is lighted by a 6/6 sash window, and all have louvered shutters. An old fashioned, metal chime doorbell is centered in the front door. The house is fronted by a small covered porch. The moderate slope "A" frame roof is covered with tarpaper and a small square chimney rises from the center of the ridge. This cottage rests on a low fieldstone foundation. It is approached by a fieldstone walk from the front brick pavement. The cottage is fronted by a picket fence and board gate which protects a dooryard garden with a small lawn, flower beds and shrubs. Old board and batten doors are used on the interior.
