**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a detached pair of 2-1/2 story frame houses, four bays wide and two in depth with a two story, full-width, frame wing, two bays in depth, and all sheathed in composition siding. Newer doors occupy the center bays and are reached by five step porches. #24 has front windows of 2/2 sash with 6/6 sash on the wing. #26 is fronted by 1/1 sash and mostly 6/6 sash on the wing with a four pane attic window. The front section has a steep slope "A" frame roof with boxed cornices and a double flue chimney rising from each gable. The wing has a low "A" frame roof with a double flue off-centered chimney rising from the ridge and both roofs are of metal. This building sets on a high fieldstone foundation.
