DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#25 is a 2-1/2 story detached frame house three bays wide and two in depth with a 2-1/2 story frame "L" shaped wing, two bays square with a side balcony. This house is now sheathed in composition siding. A newer door occupies the center bay with narrow overlights. Front windows are now of 1/1 sash with side and rear windows being 2/2 sash. The attic is lighted by small, four pane windows in each gable. Both sections have steep sloped "A" frame roofs of metal with a small, enclosed chimney on the left end and the end of the wing. The front roofline has an overhanging boxed cornice with dentil trim. The house rests on a rather high fieldstone foundation.
