DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story detached brick pair of houses, four bays wide and two in depth with a two story, brick "T" shaped wing, three bays wide and two in depth with side balconies. #36 has an added, one story, two bay deep brick extension. #38 has a two story, block extension. All brickwork is of common bond with #38 being newly faced by a shallow, bricklike covering. Newer doors occupy the outer bays with #36 retaining a three pane overlight and #38 with a newer, square covered porch. All front section windows are of 6/6 sash with wood lintels and sills (covered over on #38). The attics are lighted by four pane windows in each gable. Double flue enclosed chimneys rise from each end. The front roofline has a simple bosed cornice. The building rests on a low fieldstone foundation.
