DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#40 is a detached, 2-1/2 story frame house, four bays wide and two bays in depth with a newer, one story frame "L" shaped wing, one bay deep and two wide. The front section is sheathed by clapboarding. The front entrance occupies the right (W) bay with a newer door, three pane overlight and framed by plain pilasters and headed by a very simple pediment with dentil trim. All house windows are of 6/6 sash with louvered shutters excepting several six pane sash on the wing and left gable of the attic. The front section has a moderate slope "A" frame roof of metal and an off-centered, small chimney rises from the ridge. Rooflines are of boxed construction. This house rests on a low fieldstone foundation.
