DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#103 is an unusually tall, 3-1/2 story frame detached house, approximately three bays square with a two story, frame "L" shaped wing, 1-1/2 bays wide and four bays in depth with a side balcony. The front, right side, and rear are sheathed by asphalt shingles, with the entire left side by rock-faced embossed metal. The front entrance occupies the left (W) bay with a four panel door and four pane overlight. All house windows are of small, 6/6 sash. The front section has a moderate slope "A" frame roof with a small enclosed chimney rising on the right end. The wing has a shed roof with several small chimneys and both are of metal. The building rests on a low fieldstone foundation but has bricked-up cellar walls.
