**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#108 is a 2-1/2 story detached brick house, four bays wide and approximately three in depth with a newer, full-width, rear block extension. The front facade is now strangely sheathed with aluminum siding. A newer door occupies the third bay from the left. All house windows are now of 1/1 sash and those on the front of the house have been modernized and "aluminumized" in framing, lintels, sills, and louvered shutters. The front section has a broad, moderate slope "A" frame roof with a small enclosed chimney rising on the right side, and the roof is covered with asphalt shingles. The house rests on a low fieldstone foundation.
