**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#109 is a two story, brick house detached on the right (E) side and is three bays wide and two in depth with a 1-1/2 story "L" shaped wing, two bays wide and four in depth with a side overhang. All brickwork is in common bond. A newer door occupies the center bay. All house windows are of small, 6/6 sash with wood lintels and sills. The front section has a moderate slope "A" frame roof resting on three string brick cornices and shares a large, square chimney with its neighbor at 107, near the center of the ridge. The wing has a shed roof and both are of metal. The house rests on a low fieldstone foundation.
