DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, two story, frame pair of houses, four bays wide and approximately three in depth with a two story, frame "T" shaped wing, two bays wide and four in depth, angled on the left (W) side and with small side balconies. This building is sheathed in clapboarding. Simple front entrances with narrow overlights occupy the outer bays and are protected by a covered porch with turned pillars. The first floor of #111 was formerly a grocery store, but the first floor windows of both houses are now of wide, 1/1 sash. All other windows are of 2/2 sash. The front section roof slopes to the rear and the wing roof is rather flat, both being of metal. The roofline is fronted by a simple boxed cornice. The houses rest on a low fieldstone foundation with bricked-up cellar walls.
