#114 is a detached, two story, frame house, two bays wide and four in depth. It is sheathed with clapboarding. A period door occupies the right bay and is protected by a wide covered porch. All house windows are of 2/2 sash including that in the front gable. This gable is decorated by rows of chevron-dogtooth shingles. The house has a moderate slope, slate "A" frame roof with the gable facing the street and with two small chimneys. The house rests on a low fieldstone foundation.
