**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a detached, 2-1/2 story row of frame houses, six bays wide and two in depth with #115 having a frame, "L" shaped, 2-1/2 story wing, 1-1/2 bays wide and four in depth with a side balcony. #117 and 119 share a 2-1/2 story frame "T" shaped wing, three bays wide and four in depth with side balconies. #115 is now sheathed with asphalt siding while the others retain narrow wood siding. Simple front entrances occupy the right bays of #115 and 119 and the left bay of #117 and are protected by individual covered porches with #117 and 119 retaining turned pillars, #115 & 117 retain four panel doors with top sections now in glass, and all have narrow overlights. There is an enclosed passageway to the rear yards between #115 & 117. All front windows are of 1/1 sash except that #117 and 119 retain first floor Victorian top sashes of bordering small panes of stained glass and #115 of a somewhat similar arrangement. Rear windows are all of 2/2 sash. Each facade is crowned by centered pediment on the front roof containing a small, round arched, 1/1 sash attic window and there are also small windows in the rear wing gables. The front section has a steep sloped "A" frame roof and the steep sloped pediments. The wing of #115 has a shed roof and the "T" wing has a moderate slope, "A" frame, all of metal. This building rests on a low fieldstone foundation with brick cellar walls.
