## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#116 is a detached, two story, frame house, two bays wide and four in depth. It is now sheathed in asbestos shingles over clapboarding. A period door occupies the right bay and is protected by a wide covered porch. A newer, triple window is set beside the door, but other house windows are of 2/2 sash, including that of the front gable. The house has a moderate slope, slate "A" frame roof with the gable facing the street, and there are two small chimneys. This gable is decorated by shingles and rows of chevron dog-toothed shingles. The house sets on a low fieldstone foundation.
