DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#124 is a detached, two story, frame house, two bays wide and four in depth and sheathed with asphalt shingles. A period door occupies the right bay and is protected by a wide covered porch with turned pillars. All house windows are of 2/2 sash including that in the front gable. This gable is shingled and decorated by rows of dog-toothed chevrons. The house has a moderate slope, slat "A" frame roof with the gable facing the street and with two small chimneys. It rests on a low fieldstone foundation.
