DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, two story brick pair of houses, four bays wide and approximately five bays in depth with rear balconies. Period doors occupy the outer bays protected by covered porches with turned pillars and Victorian-cut brackets. All windows are of 1/1 sash with two row header segmental brick arches with those on the front having infills decorated by roundels as above the doors. The metal roof slopes to the rear and is fronted by a boxed cornice with the frieze decorated by a band of dentils supported by Victorian-cut brackets at each end. The houses set on a low fieldstone foundation with high brick cellar walls and are fronted by a brick pavement. The walls are of "seconds" brick from the nearby Schiltnecht Brickworks and laid in common bond.
