DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, 2-1/2 story, frame pair of houses, four bays wide and two in depth with a two story, frame "T" shaped wing, three bays wide and two in depth with a full-width, one story extension. The building is now sheathed with asphalt shingles. Newer doors occupy the end bays. The front windows are now of 1/1 sash with louvered shutters and rear windows are of 2/2 sash. The attics are lighted by small windows in each gable. The front section has a moderate slope "A" frame roof with a small chimney rising from the center of the ridge. This is fronted by a boxed cornice continuing around the corners and adorned with a very attractive frieze consisting of bands of dentils and moulding. Victorian-cut brackets with pendants divide and end the bays. The wing has a low "A" frame roof and both are of metal. The building rests on a low fieldstone foundation.
