DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#203 is a 19th century, 2-1/2 story detached frame house built on an "L" shaped plan, two bays wide and deep with a side 1/2 bay wide gabled extension and a two story, frame wing, two bays square. The house has recently been completely sheathed with asbestos siding. A covered porch fronts the house and continues around the right side to protect the main entrance with a newer door. All windows are of either 1/2 or 1/1 sash. The gable end of the house faces the street with a moderate slope "A" frame roof, the moderate sloped pedimented extension and a double flue chimney rises at the center junction. The wing roof is rather flat and all are of metal. Front section roofing projects over the walls and is decorated on the front by Victorian scrolled brackets. The house sets on a rather high fieldstone foundation.
