DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story detached pair of frame houses, four bays wide and two in depth with a two story, frame "T" shaped wing, three bays wide and three in depth on #206 and two deep on #208, which also has a one story, frame, one bay deep extension. The building is sheathed with clapboarding. Glass over panel doors occupy the end bays and all front windows are of 1/1 sash. The wing of #206 has 2/2 sash and #208 has 1/1 sash. The attics are lighted by small windows in each gable and #206 has an additional double 1/1 sash peaked dormer window on the rear slope. The front section has a rather steep slope "A" frame roof with a small chimney centered on the ridge. This is fronted by an overhanging boxed cornice with the frieze decorated by a band of dentils. Small Victorian-cut brackets with pendants divide and end the bays. The wing roof is rather flat and both are of metal. These houses rest on a low fieldstone foundation and #208 is fronted by a brick pavement.
