**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a detached, two story, brick pair of houses, five bays wide and approximately five bays deep with a rear balcony. All brickwork is in common bond. Front entrances occupy the outer bays with period doors and narrow transoms. An enclosed passageway to rear yards is in the center bays. All house windows are of 1/1 sash with two row brick segmental arches as over the doors and passageway. The metal roof slopes to the rear and is fronted by a boxed cornice with dentil trim. The building rests on a low fieldstone foundation and is fronted by a herringbone brick pavement.
