DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story building. It is constructed of red brick laid in common running bond. The trim is wood painted white. It has a metal covered gable roof sloping towards the front and back of the building.

The first story front is composed of a storefront and on the left an entrance to the upstairs apartments. The storefront has its entrance between two display windows. Under these windows are low brick planters. Both entrances have limestone steps and the doorway to the upstairs has a brownstone stoop with wrought iron railings in a scroll design. The storefront windows and entrance have transoms and elliptically arched heads. The apartment entrance has a transom and a wood panel over which is another elliptical arch. Above these arches, a simple wood cornice is carried across the whole front. This is supported by a bracket at either end.

The second floor facade has four double hung 2/2 sash windows. These have wood sills and segmented brick arches, as well as louvered wood shutters.

Over these windows is a wood cornice with a carved frieze board below it. The cornice is supported on brackets at the corners and between the windows. At the north end of the roof ridge is a small brick chimney.
