DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, 2-1/2 story frame pair of houses, four bays wide and two in depth with a 2-1/2 story, "T" shaped wing, three bays wide and four in depth with enclosed side balconies. #217 has been sheathed in asbestos siding but #219 retains original clapboarding on the front and asphalt shingles on side and rear areas. Newer doors with narrow overlights occupy the outer bays and #219 is protected by a covered porch with turned pillars. All front windows are now of 1/1 sash and the wing has 6/6 sash. The front section and wing attics are lighted by small, four pane windows in the gables. This front section has a steep slope "A" frame roof and the wing has a moderate slope "A" frame roof, both of metal. There are no chimneys on the front section, but on the wing. The building rests on a low fieldstone foundation.
