DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, 2-1/2 story house, two bays wide and four in depth. The original clapboarding has been covered with asphalt shingles but the original wood shingles are retained on the front gable. The front entrance occupies the right bay with a newer door and is protected by a covered porch with turned pillars. All house windows are now of 3/1 sash and a small, four pane window lights the attic from the front gable. The house has a moderate slope "A" frame roof of slate and a small chimney rises off center from the ridge. The house rests on a low fieldstone foundation.
