**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a detached pair of two story, brick houses approximately four bays square with a full-width wing, two bays in depth and rear balconies. All brickwork is in common bond. Front entrances occupy the inner bays with glass/panel doors and narrow overlights. Front windows are of 1/1 sash with two row, brick header segmental arches as above the doors. Rear windows are of 2/2 sash with wood lintels and sills. The front section roof slopes to the rear and the wing has a low "A" frame, both of metal. The front roofline has a Victorian "V" shaped cornice and frieze trimmed with bands of mouldings and pointed panels with narrow brackets dividing and ending the houses. The building rests on a rather low fieldstone foundation and is fronted by a brick pavement.
