DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a tall, well proportioned, old Federal pair of houses, detached, of 2-1/2 story brick construction, four bays wide and three large bays in depth with a 2-1/2 story, brick "T" shaped wing, three bays wide and two in depth with a one story, brick extension. All brickwork is in common bond. Simple front entrances occupy the inner bays with narrow overlights and #243 retains a four panel door and a covered porch with turned pillars. First floor windows are of 6/1 and 1/1 sash, but those above and in the wing remain 6/6 sash, all with wood lintels and sills. The attics are well lighted with each house having a 6/6 sash peaked dormer window on the front and rear slopes and the wing has small, four pane windows in the end gable. Both the front and rear sections have moderate slope "A" frame metal roofs with wide enclosed chimneys on the ends. The front section roof rests on three string brick cornices and the wing roof on two string brick cornices. The building rests on a low fieldstone foundation.
