DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#246 is a 2-1/2 story, detached frame house, four bays wide and two in depth with a frame, two story, "L" shaped wing, two bays square and a side balcony. A glass over panels door occupies the third bay from the left with a rectangular transom. All front windows are now of 1/1 sash and wing windows are of 2/2 sash. The attic is lighted by a small, four pane window in each gable. The front section has a steep slope "A" frame roof with an attached chimney rising on the left side. This is fronted by a boxed cornice and wood frieze trimmed by a band of dentils and small Victorian-cut brackets divide and end the bays. The wing has a shed roof and both are of metal. The house sets on a high fieldstone foundation and is fronted by a brick pavement.
