DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#7 is a small, 1-1/2 story brick house detached on the right (E) side and two bays square with a full, two story, brick "L" shaped wing, 1-3/4 bays wide and three in depth with a side balcony. All brickwork is in common bond. The front entrance occupies the right bay with a newer door and an old, narrow, four pane overlight. All windows are of 6/6 sash except the top story front windows which are of the 4+4 casement "lie on your stomach" type. There are four panel and board and batten wing doors. The front section has a moderate slope "A" frame roof with a two string brick cornice and with a square enclosed chimney rising from the left side. This is joined at the ridge by the higher, steep shed roof of the wing which slopes to the right side. This house sets on a rather high fieldstone foundation.
