DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#9 is a 2-1/2 story brick house detached on the left (W) side and is two bays wide and approximately three bays deep with a 1-1/2 story, brick "L" shaped wing one bay wide and two in depth. All brickwork is in common bond and the front has been restored displaying old salmon colored brick. The front entrance occupies the right bay with a newer door and old, four pane overlight. All house windows are now of 1/1 sash including the small attic window. The front section has a steep sloped "A" frame roof resting on two string brick cornices and with double flue enclosed chimneys rising from each gable. The wing has a steep shed roof with an enclosed chimney and both are of metal. This house rests on a rather low fieldstone foundation.
