**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#11 is a 1-1/2 story frame detached house, three bays wide and two deep with a lower, "L" shaped brick wing, 1-1/2 bays wide and three in depth. This is said to be of log construction by an older neighbor and is now covered by brick "patterned" tarpaper. The front entrance occupies the center bay with a newer door. Front windows are of 2/2 sash with small, 4+4 casement "lie on your stomach" windows in the top story. The wing has 6/6 sash windows with wood lintels and sills and an old board and batten door. The attic is lighted by two, six pane sash windows in the left gable and one 2/2 sash window in the right side. The front section has a moderate slope "A" frame roof with box cornices and a double flue enclosed chimney rising from the left end. The wing has a steep shed roof with a chimney in the center of the ridge and both are of metal. The house rests on a low foundation.
