DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story detached pair of brick houses, four bays wide and two bays in depth with a 1-1/2 story, brick "T" shaped wing, three bays wide and two in depth and a frame extension of the same size covered with asphalt shingles. All brickwork is in common bond. Front entrances occupy the end bays with four panel doors and three pane overlights. All front windows are of 6/6 sash with wood lintels and sills, as on the first floor of the wing, but those on the upper stories are of 4+4 casement "lie on your stomach" types. The rear extension has small, six paned hinged windows. There are four panel doors on the wing. The attics are lighted by small, four pane windows in each end. The front section has a moderate slope "A" frame roof resting on two string brick cornices. Double flue enclosed chimneys rise from each gable. The wing and extension have steep slope "A" frame roofs with a wide chimney rising at the end of the wing and both are of metal. This building rests on a low foundation.
