**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#20 is a very small, old, 2-1/2 story frame house (now a shack) approximately two bays square with an added, full-width rear addition of one bay in depth and topped by a steep shed roof (catslide) from the gable. This building is detached on the right side and is possibly of log construction now covered with clapboarding on the front and brick patterned tarpaper on the side and rear. A small, four panel door occupies the right (W) bay. Front windows are of small, 6/6 sash with louvered shutters and there is a small, four pane attic window. The front section has a steep "A" frame roof joining the long shed-roofed extension, and both are of metal. This house sets on a low foundation and is fronted by a narrow brick pavement.
