**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a row of four, two story brick houses, detached on the left (E) side and are eight narrow bays wide and approximately four bays deep with no wings. All brickwork is common bond. Turn-of-the-Century, six panel doors occupy the first, fourth, fifth, and eighth bays from the left. First floor windows are of 2/2 sash with second story front and all rear windows 6/6 sash. All have flat brick arches as do the doors. Rear doors are of board and batten. The metal roof slopes to the rear. The front roofline has a boxed cornice with the wooden frieze neatly trimmed by a band of dentils, mouldings and small Victorian-cut brackets. This building sets on a low fieldstone foundation and is fronted by a brick pavement.
