DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, two story pair of brick houses, four bays wide and approximately five bays in depth with rear balconies and no wing. All brickwork is in unpainted common bond. Segmental arched, turn-of-the-century front doors occupy the inner bays with a covered porch supported by Doric columns crossing the front. All house windows are of 1/1 sash with two row brick segmental arches. The metal roof slopes to the rear. The front, Victorian "V" shaped cornice is trimmed by bands of moulding and incised designs. The building rests on a low fieldstone foundation.
