DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, two story brick pair of houses, four bays wide and approximately five in depth with partially enclosed rear balconies and no wings. All brickwork is in common bond. Segmental arched, turn-of-the-century doorways with narrow overlights occupy the end bays and the building is fronted by a high covered porch with turned pillars. All front and side windows are of 1/1 sash with two row brick header segmental arches, except second story side windows which have wood lintels and sills. Front windows have the infills decorated with incised scrollwork and there are no rear windows. The metal roof slopes to the rear and is fronted with a plain boxed cornice with dentil trim. The building rests on a low fieldstone foundation.
