**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a detached row of two story brick houses, nine bays wide and two bays in depth sharing two "T" shaped, brick, two story wings, approximately three bays square with rear balconies. The center bay on the first story contains an enclosed passage to the rear yards. Turn-of-the-century, segmental arched doorways with narrow overlights occupy the outer bays of each pair, and high covered porch with turned pillars fronts each pair of houses. All front and side windows are of 1/1 sash with two row header brick segmental arches and infills on the front are decorated by roundels. Rear wing windows are of narrow 1/1 sash with wood lintels and sills. The front section roof slopes to the rear and the wings have low, "A" frames with all being of metal. The front roofline has a moulded, boxed cornice with dentil trim and rather plain brackets accent house divisions. The building sets on a rather high fieldstone foundation.
