DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached, 2-1/2 story, stuccoed cottage-style house approximately three bays square with rear galleries. The front entrance occupies the right bay (W) with a period glass paned door and is protected by a wide covered porch of heavy masonry, stuccoed and trimmed with formstone. To the left is a set of three 6/1 sash windows with the center being wider. Other house windows are also 6/1 sash and are framed by flat architrave. The attic is lighted by double-hipped, roofed dormer windows of six panes. The house roof is also hipped and covered by asbestos-type square tiles. This overhangs all four walls with the dormer and porch roofs being of the same design and supported by shaped beams. The house rests on a low foundation.
